### **TERMS OF AGREEMENT : Minimum of 40 golfers**

1. **A non-refundable \$500 deposit** must accompany this document to book any tournament and hold your tee times. It will be credited to your final bill. This deposit can be taken from a credit card or a mailed check to Harbor Golf Club & Resort.
2. An estimate of the number of golfers must be supplied to the pro shop **upon booking** the tournament. A minimum charge of **95% of the booking numbers** will be applied to the tournament. Final numbers must be confirmed **no later than 3 days** prior to the tournament.
3. The tournament draw and any special requests for long drive and closest to the pin competitions must be supplied to the pro shop **no later than 3 days** prior to the tournament.
4. **The tournament organization acknowledges and accepts responsibility for any damage to the golf course, golf carts, rentals or the clubhouse. Tournament organization may request Individual player sign liability forms for power cart or golf club rental. Harbor Golf Club & Resort assumes no responsibility for the loss of personal property**
5. **Harbor Golf Club & Resort Inc. will be the sole supplier of food and beverage items. All players will be informed by the tournament director that Harbor Golf Club & Resort Inc. (the complete property) is a Licensed Premises. It is unlawful to bring alcoholic beverages on to the premises, including the parking lot. All alcoholic beverages must be purchased in the clubhouse or from the courtesy cart. Violators will be removed with no refund.**
6. The tournament will go as scheduled, unless the course is deemed unplayable by Harbor Golf Club & Resort Inc. management. At which point the tournament will be rescheduled or deposit monies refunded.
7. Final payment of all green fees, cart fees, and food costs (where applicable) are due on the day of the tournament *prior to the first group teeing off.* Unless prior arrangements have been made. Cash, cheque, debit card, Visa, Amex and MasterCard are accepted.
8. There will be a **charge of 25% of the booking value** for any tournament cancelled with in 30 days of tournament date.
